## **Regulations for corporate sponsored banner to be displayed at Athletic Events**

- **Corporate sponsor must submit a written proposal using the school issued form to the Director of Athletics for recommendation to building principal, who will send it to the Superintendent. Final approval will come from BOE**
- **Banners will be uniformed in size, color and will have the corporate sponsor name and contact information with a limit of 4 lines.**
- **Banners will be made either at Northern Burlington or a company designated by Northern Burlington with the cost being absorb by the corporate sponsor from the advertising fee.**
- **Each banner will be assessed an advertisement fee for the corporate sponsor for displaying at athletic events for two seasons**
  - Fee- Football stadium from September 1 to November 30 or until the last home Football game for two years will be \$500**
  - Fee- Field Hockey or Soccer Fence from September 1 to November 30 or until the last schedule game for two years will be \$200**
  - Fee- Softball/Baseball Outfield fence from March 15 to June 1 or until the last schedule home game for two years will be \$200**
  - Fee- Boys and Girls Lacrosse Fence from March 15 to June 1 or until the last scheduled home game for two years will be \$200**
  - Fee- Girls and Boys Track fence from March 15 to June 1 or until the last scheduled home meet for two years will be \$200**
- **If the banner display is terminated by BOE the fee will be prorated based on the number of home contests played less the cost of the banner and the banner will be returned.**
- **Proceeds from the banner sale will go to the sport's booster club, with the money being deposited in the sport's activity account through the Athletic Office.**
